#### THIRD AMENDMENT TO BYLAWS FOR EAGLE'S BLUFF

This Third Amendment to BYLAWS FOR EAGLE'S BLUFF ("Declaration") is made on the date hereinafter set forth by the Board of Directors for Eagle's Bluff Community Association, Inc. ("Association").

WHEREAS, Association filed a First Amended Bylaws for Eagle's Bluff Community Association, Inc., Cherokee County, Texas, on August 11, 2014, and it was recorded as Document Number 00637131; and

WHEREAS, Association filed a Second Amended Bylaws for Eagle's Bluff Community Association, Inc., Cherokee County, Texas, on September 20, 2017, and it was recorded as Document Number 00665600; and

WHEREAS, Association desires to further amend the Bylaws.

NOW THEREFORE, the Bylaws are hereby amended accordingly:

1. Article 3.6 of the Bylaws is hereby deleted in its entirety and replaced with the following:

#### 3.6. Voting Rights:

The Association shall have multiple classes of voting membership, including but not limited to "Class A", "Class B", Class "BH", and Class "0". Additional classes of Membership may be added by the Declarant via Supplemental Declaration(s), but requires Board approval.

- (a) The definitions of Unit types under Section 1.27 of the Declaration classify which Owners are Class "A" Members, Class "BH" Members. Article 3.3 defines Class "0" Members as a membership classification for all Owners not assigned to any other Member Class. If such Owner is a group or entity other than one (1) individual person, the vote on behalf of such Owner shall be exercised as such co-Owners determine among themselves and advise the Secretary of the Association in writing prior to any meeting.
- (b) Class "B". The sole Class "B" Member shall be the Declarant. The Class B Member shall be entitled to two (2) votes for each Unit owned. The Class B Membership shall cease and be converted to Class A Membership according to the method set forth in Section 3.3 of the Declaration.

All voting rights of Members are subject to the restrictions set forth in the Declaration and elsewhere herein.

### All other terms and conditions and Exhibits shall remain in full force and effect.
